- ** In order to be eligible for the Start-Up Contractor designation, your company must meet ALL of the following criteria:
1. Provide official business license noting start-up year of 2016, 2017, or 2018
 2. Total annual volume of less than \$500,000 at the time of becoming a member
 3. Not a current or past ABC member at any other Chapter
 4. Commit to a GC or Subcontractor Category following a maximum of 2 years at the Start-up Contractor dues level

Definition of Member Constituents:

A Contractor is a person, a firm, or a corporation which is directly involved in building or construction

A Supplier is a person, firm, or corporation which is not responsible for on-site labor

An Associate is a person, firm, or corporation, which is neither a Contractor nor a Supplier, providing services to the construction industry, but not directly involved in construction; *does not supply direct labor and/or materials on-site*
